Privacy Notice

Who are we?

References to 'us' or 'we' are references to Technology To Go Ltd. Our company registration number is 07465303.

What is the purpose of this Privacy Notice?

Your privacy is very important to us. The purpose of this Privacy Notice is to explain who we are, the Personal Data we collect, how we collect it and how we use it. Do we collect Personal Data from third parties?

This data has been given by consent, at the point of collection and is used only for the purposes of legitimate business-to-business marketing.

How will we use your Personal Data?

We must always have a lawful basis for using personal data. Your personal data may be used for one or more of the following specific purposes:

How long will we hold your Personal Data for?

If you have entered into a contract with us, we will retain your Personal Data for a minimum of seven years after the cessation of the contract. Otherwise, we will delete your personal data twenty-four months after our last contact or attempted contact with you.

What are your rights in relation to the Personal Data that we hold?
